Geis expands management level of the business division Road Germany

After that, Jörg Rotthowe will become the sole Managing Director, while Klaus Stäblein will continue to manage special projects for the Geis Group until his retirement at the end of 2025. Klaus Stäblein has held various management positions at the Geis Group since 1988 and has very successfully managed the Road Germany division since 2006.
